- b. ESO Tablet data transfer update
 - i. Status of RFLFPD authorizing ESO data with UCH?
 - 1. Bill asked Chief Hill to advise when he had contacted ESO for permissions with UCH.
 - 2. Once ESO permissions secured, PFA will work with UCH to coordinate ESO patient information access.
 - ii. Warren GVFPD will be going to ESO in the near future if funds approved by the board.

4. QA Update

- a. Status of access to NLCERA rural EMS reporting RMS by PFA for QA
 - i. Currently, PFA EMS has access to GVFPD ER, RFL/CL ESO, WFPD ER
 - ii. Discussion: Regarding a Procedure for accessing all cardiac arrest data from rural NLCERA departments AED's.
 - Once the EMS Contract amendments are signed, PFA will be working with the NLCERA departments to establish a process to retrieve cardiac arrest data for QA and feedback.
