EMS Advisory Committee Meeting

Minutes of the meeting which was held on **August 21, 2019, 08:30 – 10:00**, at PFA Station 12, 321 Country Club Rd, Downstairs Training Room

Agenda and Discussion Items:

- 1) Welcome existing and new members (see roster)
 - a. Daniel Alarcan RFLFPD
 - b. George Solomon UCH EMS Education Coordinator
- 2) Approval of June 19, 2019 meeting minutes
 - a. Minutes approved no discussion.
- 3) Review Purpose and Mission
- 4) PFA NLCERA Updates
 - a. NLCERA EMS System Improvements Plan (See Ribbon Graphic)
 - i. Kevin presented an overview of how the current EMS Contract is measuring response capability from dispatch to on scene, then basically nothing after arrival. He shared a graphic (see <u>Appendix A</u>) which shows a ribbon interwoven into a star with each of the five pillars. EMS Compliance will be measured from now and into the future through these five pillars (See <u>Appendix B</u> for NLCERA Administration Organizational Chart). See below the descriptions of how we are using each pillar:
 - b. Introduction of the Five Pillars of EMS Compliance
 - i. Protocols
 - a. Informs how the Medical Director requires pre-hospital EMS to be performed.
 - b.Current protocols are color coded and linked for ease of use.
 - c. Will be updated in January and July of each year.
 - d. Issue presented regarding color blind personnel and possible solutions.
 - 1. Kevin to follow-up and research adjusting headings for consistency for those with limited color differentiation.
 - ii. Response
 - a. Response times are the measurement basis of most EMS contracts.
 - b.Important, yet doesn't account for what happens after arrival on scene.
 - c. Remediation Equivalency ensures continual improvement focus
 - iii. Quality Assurance
 - a. Reviewing of patient care information for quality assurance is an important part of holistic EMS compliance measures.
 - b.QA is now a major emphasis moving forward for the NLCERA.

c. Example: Cardiac arrest responses are fully evaluated through the QA process and feedback per the protocols provided to responding crews.

iv. Equipment

a. The coordination of equipment for compatibility, training and cost is a significant focus serving the Fire/EMS agencies of the NLCERA.

v. Training

- a. Training coordination between PFA and UCH in support of all NLCERA EMS providers ensures high quality and focused training in support of EMS certifications.
- b.Examples:
 - 1. EMT (all levels) new hire field training programs will extend to all NLCERA agencies.
 - 2. MedicCE captures certification and training information for all NLCERA EMS providers.
- c. Adding Pillars of EMS compliance reporting to agenda format
- 5) Bill requested of the committee to add the Pillars of EMS compliance to the agenda format. No issues noted.
- 6) NLCERA Contract Administration (See Org Chart)
 - a. Kevin introduced the NLCERA Administration organizational chart. This chart breaks down the roles and responsibilities for collaborative work between PFA and UCH to serve the EMS needs of the NLCERA.
- 7) Following up: System Changes Status from June Minutes
 - a. MARVLIS Implementation
 - a. Being implemented today, August 21, 2019.
 - b. Will help predict UCH ambulance placement for more reliable EMS response.
 - c. UCH using static and dynamic posting models within MARVLIS.
- 8) FC911 Transfers Addition of BLS Ambulance
 - a. The current EMS contract does not allow only a BLS response for calls originating from FC911. PFA and UCH are establishing a new criterion toward right size resources for 33A Interfacility Transfers (IFT).
 - b. As of September 3, 2019, when FC911 receives requests for interfacility transfers (IFT) which EMD code as 33A, a three tiered response will be initiated in the following order: BLS ambulance > UCH270/249 > or ALS ambulance.
 - c. By allowing BLS IFT's for 33A responses, the UCH ALS units can remain available for more serious responses in the NLCERA.
 - d. Discussion ensued from Dr. Tremblay about other EMS response determinants which might qualify for a right size adjustment of resources.
 - i. The BLS IFT changes are the first opportunity to right size resources.
 - ii. As QA effectiveness and data become available, other EMS response determinates within the emergency medical dispatching sequence will be considered.
- 9) New Map Validation
 - a. The new NLCERA map was adopted by Amendment #5 to the EMS Contract on June 1, 2019.

b. The response data is showing the new map zones, which are GIS validated routes, is working as expected. This map reflects what response coverage should be possible for the entire NLCERA.

10) NLCERA.org website

a. Poudre-Fire.org for NLCERA will be linking directly to NLCERA.org in the near future.

11) UCHealth updates

- a) UCHealth EMS Organizational updates
 - i. Mike Ramsey hired to be over QA for UCH EMS.
 - 1. Mike is building a QA program which will bring all response and patient care data together in one place.
 - ii. Judson Smith hired to be over the UCH Community Medicine.
 - 1. Judson will be focusing on patients through the hospital system.

12) NLCERA Second Quarter Data

- a. April June, 2019 Compliance Zones 1-5 overview showing the data is stable with known response exception issues in zone 1 non-emergent and zone 2 emergent.
 - i. These response deficits are a significant focus of current and ongoing R-E plans.
- b. New map response data update
 - i. The new NLCERA map appears to be much more reliable regarding assessing response times.

13) NLCERA July Remediation-Equivalency (R-E) Status

- a. Brief Overview of July R-E
- b. The July R-E was held up as an example of how the response data is being evaluated through the DMAIC (Define-Measure-Analyse-Improve-Controls) process.
 - ii. Many data controls are currently being assessed, with continual improvement as the goals.
 - iii. Bill invited any committee member wanting more detailed information to contact him for a meeting.
- 14) Focused discussions on Challenges and Opportunities regarding:

 - i. New CAD Process updates
 - 1. Discussion and update that new CAD is on target for March 2020 implementation.
 - ii. LC Hiplink & Paging systems updates
 - 1. Discussion about pagers still having issues in the rural NLCERA.
 - 2. Bill to follow-up regarding Hiplink access and advise the rural chiefs.
 - iii. Follow-up:
 - 1. Communication interface with FRCC?
 - 2. Bill advised this remains on our agenda due to concerns interfacing with FRCC communications on large events.

 - NLCERA EMS training has changed didactic emphasis to include shorter class and longer practical sessions.
