- 1. NLCERA EMS Rural Chiefs Update September 30/October 7 Meeting Minutes
 - a. Posted on <u>www.NLCERA.org</u> Website (EMS Contract > Rural Chiefs > 2020 > September).
- 2. EMS Contract Amendments status
 - a. Chief Waters is finalizing and confirming updates with PFA legal before sending the document back to UCH legal for final agreement.
 - b. PFA is currently planning to present the EMS Contract Amendments to the PFA Board.
 - i. Chief waters described the current process and hoping to bring the new amendments to the EMS contract to the PFA Board in November.
- 3. New CAD updates
 - a. IT and AVL Updates
 - i. If you experience suspected CAD related response issues please submit the NLCERA Operational form for follow-up.
 - ii. Reassignments How may these affect response to the rural NLCERA
 - 1. This CAD sees all available fire and EMS units equipped with AVL.
 - 2. CAD is programed to prioritize EMS calls by priority: Non-Emergent to Emergent.
 - 3. If your ambulance is enroute non-emergent and CAD sees it as the closest unit to a higher priority call (emergent) they will automatically be reassigned.
 - 4. The FC911 Dispatcher will manually dispatch another ambulance to your call. 900 will also see this on their CAD screen.
 - 5. You may experience a delay for non-emergent responses due to reassignments.
 - Please submit a NLCERA form for any calls you have questions about (NLCERA.org > Contact Us > Operational Feedback Form).
 - a. Question: if two units are enroute emergent to Hwy 14 and Redfeather, and one ambulance should be closer to the other call will CAD reassign them?
 - i. Answer: No, verified with PFA IT (Mark Regan) that this is not how CAD is programed.
- 4. Third quarter data status
 - a. Due to the new CAD implementation, the First Watch (FW) data compliance program is being reprogramed and validated.
 - b. All data should be available and assessed for compliance by November 19, 2020.
 - c. Third quarter EMS response compliance reports available after November 19, 2020.
 - i. PFA will bring the third quarter data, as well as the first two months under the new CAD, to the November monthly update meeting.
