- 1. NLCERA EMS Rural Chiefs Update October 28, 2020 Meeting Minutes

- 2. Retirement: As of January, 2021, PFA Division Chief Ryan McLean is retiring from PFA to take a position as Senior Director of Prehospital Care for the UC Health System.
 - a. Ryan has been the Support Division Chief at PFA over the NLCERA EMS Contract.
 - b. Division Chief Vander Velde will move into the Support Division and assume responsibility for the NLCERA EMS Contract.
 - c. Chief Waters remains the Administrator over the NLCERA EMS Contract.
- 3. EMS Contract Amendments status
 - a. Status update
 - i. PFA is working directly with City of Fort Collins Legal and continues to refine the proposed update language.
 - ii. A new NLCERA Map has been created after many hours of effort with PFA GIS and EMS staff. This map will be utilized with the amendment response time structure and reflects the most updated and leading-edge formula for response zone creation and growth.
 - iii. PFA will continue to keep all NLCERA agencies informed as the amendments are finalized with UCHealth.
- 4. WFPD now under the NLCERA EMS Contract
 - a. What this means to the NLCERA is that the ambulance in Wellington is now a NLCERA resources and is dispatched as the closest unit.
 - i. Glacier View saw UCH220 this week during a response.
 - b. Data from the WFPD responses are now included in the greater body of NLCERA response data for calculating EMS response compliance in zones 1-4.
